SUBJECT:

Telephone System Upgrade - Ghazvini Center for Healthcare

Education

### Item Description:

This item describes the cost to upgrade the Main Campus Telephone System to accommodate the Ghazvini Center for Healthcare Education.

#### Overview:

The College has been steadily moving to upgrade the telecommunications system on the Main Campus. The existing telecommunications system does not have the capacity to handle the added load of the new Ghazvini Center without substantial upgrades.

#### Salient Facts:

The current telecommunications provider for the TCC Main Campus, Avaya, has provided the cost, based on State Contract pricing, to upgrade the current system and provide the same system service to the Ghazvini Center. This upgraded system would also upgrade the systems that service both Quincy House and the TCC Downtown Center since they are part of the Main Campus system.

The cost of the upgrade, as per State of Florida Contract 730-000-09-1, to the Main Campus and the added cost to include the Ghazvini Center is \$319,387.13. Since this cost exceeds the authorization of the President, it must be presented to the District Board of Trustees for approval.

All of the funding for this upgrade is available as part of the project costs for the Ghazvini Center.

#### Past Actions:

There were no previous actions required by the District Board of Trustees.

### **Future Actions:**

No future District Board of Trustees action will be required on this item.

### Funding/Financial Matters:

The funds for this project are available as part of the Ghazvini Center project funds.
