Overview:

Pursuant to the Board's recommendation to update the TCC Board Policy Manual, Chapter 10 policies were submitted for Board approval in May 2010. After further review of the authorities for Chapter 10, we have deleted all references to Florida Administrative Code 6A-14.0247 and 6A14.0262 for the policies contained in this chapter. The policies on the portal were updated on May 17, 2010 to reflect the deletion.

Salient Facts

Chapter 10 policies were revised to ensure compliance with new state and federal laws; reflect modifications to the College's organizational structure; and to remove procedures from policy.
