Item Description:

This item requests that the Board approve the receipt of funding for the listed projects.

Overview:

The following are recommended for approval:

I. RECEIPT, AMENDMENT, EXTENSION OF RESOURCES

Florida Department of Education – English Literacy/Civics Education for Gadsden County

This award integrates education services to immigrants and other limited English proficient populations in Gadsden County to acquire the basic skills they need to function effectively as parents, workers and citizens. The award is for \$26,982, with an indirect cost rate of 5%. The funding period is from 7/1/2010 through 6/30/2011.

Florida Department of Education – English Literacy/Civics Education for Leon County This award integrates education services to immigrants and other limited English proficient populations in Leon County to acquire the basic skills they need to function effectively as parents, workers and citizens. The award is for \$49,329, with an indirect cost rate of 5%. The funding period is from 7/1/2010 through 6/30/2011.

Florida Department of Education – Adult Education and Family Literacy, Adult General Education (Leon County)

This award will provide voluntary adult education and literacy services in Leon County in order to increase performance measures on standardize testing and obtain the educational skills necessary to be involved in the education of their children. The award is for \$178,599, with an indirect cost rate of 5%. The funding period is from 7/1/2010 through 6/30/2011.

Florida Department of Education – Adult Education and Family Literacy, Corrections (Gadsden County)

This award will provide corrections education for institutionalized individuals in Gadsden County. The courses will address the five curricular areas of the GED Exam: Language Arts/Writing, Language Arts/Reading, Social Studies, Science, and Mathematics. The award is for \$96,886 with an indirect cost rate of 5%. The project period is from 7/1/2010 through 6/30/2011.

Florida Department of Education – Adult Education and Family Literacy, Corrections (Leon County)

This award will provide corrections education for institutionalized individuals in Leon County. The courses will address the five curricular areas of the GED Exam: Language Arts/Writing, Language Arts/Reading, Social Studies, Science, and Mathematics. The award is for \$46,832 with an indirect cost rate of 5%. The project period is from 7/1/2010 through 6/30/2011.

Carnegie Foundation - Statway Collaboratory Project

This award will focus on combining faculty members from over 15 community colleges in five states to develop a modular curriculum that is designed to improve the persistence and success rates of students who are placed into developmental mathematics. The award is for \$95,000, with an indirect cost rate of 0%. The funding period is from 7/1/2010 through 6/30/2013.

Salient Facts:

The Board of Trustees has authority to contract with outside agencies for provider management.

Past Actions:

There has been no previous action by the Board on this funding.

Future Actions:

No further activity on the part of the Board is necessary.

Funding/Financial Matters:

The above projects will be established in a Fund 2, Restricted Accounts. The indirect earned from these awards will be \$18,983.

Overview:

The following are recommended for approval:

I. RECEIPT, AMENDMENT, EXTENSION OF RESOURCES

Department of Juvenile Justice – Officers in Training Program
This contract will provide funding to the Florida Public Safety Institute (FPSI) to cover
the tuition, lodging, and meals for employees of the Department of Juvenile Justice
(DJJ) in various training courses offered by the at the FPSI for training its Detention,
Residential and Probation Officers. The total contract amount is \$1,667,442.66, with
an indirect cost rate of 0%. The funding period is from 7/1/2010 through 6/30/2013.

Salient Facts:

The Board of Trustees has authority to contract with outside agencies for provider management. DJJ has requested the creation of a multi-year contract to provide for the payment of tuition, lodging, and meals for its employees in lieu of the use of purchase orders for each class offering to facilitate long range planning of its commitments.

Past Actions:

There has been no previous action by the Board on this funding. In this and previous years, DJJ has paid for tuition, lodging, and meals using purchase orders for each individual class offering.

Future Actions:

If appropriate, the Board will be asked to approve any modifications to this contract annually.
