## Item Description:

The President has previously approved this item per TCC policy 6Hx27:03-04, as amended

#### Overview:

# I. RECEIPT, AMENDMENT, EXTENSION OF RESOURCES

Florida A&M University – Florida Georgia Louis Stokes Alliances for Minority Participation (FGLSAMP)

TCC will provide services associated with the FGLSAMP NSF Co-Operative Agreement to fund a student organization with the objective of increasing awareness in STEM disciplines. TCC will also provide and support a cohort of qualified and NSF eligible students at the College. The contract amount is \$14,225, with a modified total indirect cost rate of 5%. The contract is from 11/1/2010 through 10/31/2011.

National Science Foundation (NSF) – MESA NSF Scholarship Grant This award to provide assistance to academically talented students from socioeconomically disadvantaged backgrounds in their pursuit of baccalaureate and graduate level degrees. The amount of this award is \$2,000, with an indirect cost rate of 0%. The contract period is from 9/1/2010 through 8/31/2011.

Florida Department of Education – Administration of Postsecondary Readiness Assessments to High School Students

TCC will coordinate administering the Postsecondary Education Readiness Test (PERT). The amount of this award is \$18,114.11, with an indirect cost rate of 5%. The contract period is from 7/1/2010 through 6/30/11.

## II. COMMITMENTS, EXPENDITURES, CONTRACTS FOR SERVICES

FDOT Impaired Driving Sports Campaign – FS Florida/Sun Sports
TCC will require contractual services to provide advertising and promotional benefits to support the impaired driving campaign during several high school and profession sporting events state-wide. The amount of the contract is \$199,910, with an indirect cost rate of 8%. The contract period is from 10/25/2010 through 9/30/2011.

FDOT Spanish Language Training – Partners in Training Consultants, Inc. This contract between Tallahassee Community College and the Partners in Training Consultants, Inc. will provide qualified training instructors to teach Spanish to law enforcement officers. The contract amount is \$117,760, with an indirect cost rate of 8%. The contract period is from 1/1/2011 through 9/30/2011.

#### Salient Facts:

The Board of Trustees has authority to contract with outside agencies for provider management.

#### **Past Actions:**

There has been no previous action by the Board on this funding.

### **Future Actions:**

No further activity on the part of the Board is necessary.

# Funding/Financial Matters:

The above projects will be established in Fund 2, Restricted Account. The indirect earned from these awards will be \$1,540.
