Item Description:

Authorization of the 2010-11 Dr. Philip Benjamin Match request.

Overview:

The Dr. Philip Benjamin Matching Program for Community Colleges was established by the Florida Legislature as a way to encourage private support to benefit community college students and enhance community college programs.

Through the program, funds raised for scholarships are matched dollar for dollar. Developmental funds are matched by the State \$4 for every \$6 raised by the College.

Colleges and/or College Foundations submit reports and make match requests to the State in early February each year. Match requests are based on funds received and deposited within the previous February 1 through January 31 time period.

Salient Facts:

Between February 1, 2010 and January 31, 2011, the TCC Foundation estimates that it will receive funds for scholarships and program development as shown on the attached draft report.
