SUBJECT:

Continuing Contract Faculty Post-Award Recommendations

Item Description

This item describes the status of the post-award review of continuing contract full time faculty at TCC and recommends certain faculty for continuance of continuing contract.

Overview and Background

State Board of Education Rule 6A-14.0411 requires all colleges to establish a post-award review process for continuing contract faculty. TCC has a process in TCC Policy 05-02. The process was developed in 2013 and piloted in 2014-2015. In the 2015-16 academic year, continuing contract faculty were reviewed for post-awards. We staggered the continuing contract faculty reviews over a five-year period based upon faculty hire date. All full time faculty continue to be reviewed annually; post-award portfolios consist of selected work from a five-year period of annual reviews.

In Fall 2015, TCC had 34 faculty to develop post-award review portfolios for our post-award review process. The portfolios were submitted this summer for review by the supervising dean and recommendations were submitted to the Provost. All 34 faculty successfully completed the post-award review.

Past Actions by the Board

The Board previously approved a revision to Board of Trustees Policy 05-02. That policy describes annual and continuing contracts at TCC and requires an annual report to the Board of the status of all full time faculty contracts. This is the annual report.
