The following are recommended for approval:

I. RECEIPT, AMENDMENT, EXTENSION OF RESOURCES

- 1) Organization:** USDOJ – Criminal Intelligence Sharing Project
Scope of Service: The goals of this project are to enhance the practice of criminal intelligence with the law enforcement/ criminal justice community, demonstrate the benefits derived from the intelligence, and encourage information sharing in support of the intelligence community. This will be achieved by expanding an existing program to enhance existing infrastructure intelligence training programs at Pat Thomas Law Enforcement Academy (PTLEA) that will enable law enforcement and other criminal justice agency personnel to meet National Criminal Intelligence Sharing Plan (NCISP) standards.

Award Amount: \$178,870 Modified Total Direct Cost (MTDC)
Indirect Rate: 8%, Modified Total Direct Cost (MTDC), \$12,398
Requested Board Action: Authorize the receipt of funds for the USDOJ – Criminal Intelligence Sharing Project.
- 2) Organization:** TG Public Benefit Program – Pilot Program to Increase Nontraditional/Adult Learners Success through Scholarships.
Scope of Service: The goal of this project is to improve access to

postsecondary education by establishing a pilot program at TCC to assist Nontraditional/Adult Learners who are financially needy but do not qualify for Federal Pell and Florida Student Assistance grants. This goal will be achieved by awarding at least 100 students annual grants of approximately \$2,000, which will reduce their total loan indebtedness and unmet need. Preference will be given to students pursuing careers in technology-based fields.

Florida Department of Education - College Reach Out Program (CROP)

Scope of Service:

Continuation grant to provide funding to support outreach and postsecondary recruitment efforts for low-income and educationally disadvantaged middle and high school students for TCC and the four postsecondary education partners (FAMU, Gulf Coast Community College, Flagler College and Chipola College) that make up the Panhandle CROP Consortium.

This is a renewal award enhancing CROP's outreach efforts in Gadsden, Leon and Wakulla counties. CROP's primary goal is to increase the number potential first generation-in-college students who successfully receive a college education. The focus is on working with individuals in grades 6-12 coming from low to lower-middle incomes.

Scope of Service:

FLDOE – Century 21 Community Learning Center Project
The goal of this project is to significantly improve student achievement of at-risk students at Stewart Street Elementary School of Quincy, Florida, which serves the most impoverished area of the most economically and educationally disadvantaged County

in Florida. This will be achieved by: establishing a community learning center; providing academic enrichment, cultural and recreational activities; and engaging adult family members of students. Multi-year total award is \$1,122,528.

Scope of Service:

This new international educational exchange program will enable 4 individuals from Egypt to study at TCC to develop professional skills. The program provides funding for round-trip airfare to the U.S.; a living allowance during academic, English language, and practical training program components; tuition costs; health insurance; and cultural enhancement activities. Programs may result in either a certificate or an Associate Degree. Students are required to return home at the end of their program and may not transfer to a four-year U.S. academic institution.&
